## ORDER ESTABLISHING TIME TO RESPOND

On August 30, 2023, the Staff of the Public Service Commission filed a motion advising the Commission to cancel the Interconnected Voice over Internet Protocol (IVoIP) registration of Strongcord Infrastructure Systems Management, LLC (Company) at that company's request.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's recommendation and the company's request.

The Commission finds that proper persons shall be allowed 10 days to file a motion for hearing.

#### THE COMMISSION ORDERS THAT:

- 1. Anyone wishing to respond to Staff's recommendation or request a hearing shall do so by filing an appropriate pleading no later than September 11, 2023.
  - 2. This order shall be effective when issued.
