COMES NOW the Office of Public Counsel (Public Counsel) and, unable to reach agreement with other parties regarding the local public hearing notice, offers the attached notice, which is designed to more accurately reflect The Empire's District Electric Company's request than the notice to which it does not agree, and comply with the second sentence of the notice requirements of Commission rule 20 CSR 4240-20.090(2)(A)1:

The notice shall include a description of how its proposed RAM shall be applied to monthly bills, the amount of the proposed change in base rates caused by the rebase of energy costs, and the estimated impact on a typical residential customer's bill resulting from the rebase of energy cost.

Liberty is requesting an increase of by \$79.9 million, or approximately 12.15% and while it has filed 60 days' notice of its intent to seek securitization of \$29.9 million of that increase (See Case No. EO-2022-0040), it has not withdrawn that \$29.9 million request from this case, and undoubtedly will not have withdrawn it before the local public hearings in mid-November. The earliest Liberty can file its securitization application and comply with the statutory 60 days' notice requirement is October 27, 2021.

NOTICE OF LOCAL PUBLIC HEARINGS ON LIBERTY'S ELECTRIC RATES

On May 28, 2021, The Empire District Electric Company d.b.a. Liberty filed a general rate request with the Missouri Public Service Commission ("Commission") designed to increase Liberty's annual gross revenues from its Missouri electric retail customers by \$79.9 million, or approximately 12.15%. Liberty is proposing to increase its fixed residential customer charge from \$13.00 per month to \$16.00 per month.

If the Commission allows Liberty to recover its Storm Uri costs in Case No. EO-2022-0040, then Liberty will stop seeking to recover them in this case. Removing those costs from this case would reduce Liberty's request by \$29.9 million—from \$79.9 million, or approximately 12.15%, to \$50.0 million, or approximately 7.61%.

For a residential customer using 1,000 kilowatt-hours of electricity a month, Liberty is proposing an increase of approximately \$19.84 each month, or 15.0% percent. Without Storm Uri costs Liberty estimates that its proposed rate increase will have the following annual customer bill impacts:

Liberty is asking the Commission to authorize it to continue its Fuel Adjustment Clause ("FAC") with modifications. Liberty estimates that rebasing energy costs in its FAC reduces its annual gross revenues by \$69.3 million. In other words, if energy costs in its FAC were not rebased,

Liberty's rate increase request would be approximately \$119.3 million, but its aggregated monthly billed "Fuel Charges" would include credits totaling about \$69.3 million per year for a net increase of about \$50.0 million per year. If the Commission approves Liberty's request to continue its FAC, Libertywill continue to adjust (credit or bill) the monthly "Fuel Charge" on its electric customers' bills twice each year, on June 1st and December 1st, based on each customer's electrical usage and the difference between Liberty's actual energy cost (*i.e.*, the varying costs of fuel used to generate electricity at its generating unitsplus electric energy it purchases on behalf of its customer using 1,000 kilowatt-hours of electricity a month, Liberty estimates that the impact of rebasing energy costs in its FAC effectively moves a monthly Fuel Charge credit of about \$13.27 to a reduction in that customer's monthly usage charges by \$13.27.

Due to the ongoing COVID-19 pandemic, for public safety, rather than holding in-person local public hearings, the Commission is holding virtual question and answer sessions followed by local public hearings where members of the public may participate by WebEx video or by telephone. The Commission has scheduled question and answer sessions to begin at 6:00 P.M., Monday, November 15, 2021, and at noon, Wednesday, November 17, 2021, respectively. Each will be followed by WebEx video and telephone conference local public hearings where anyone may appear, testify, and/or provide documents to the Commission for it toconsider in this general electric rate case. Each local public hearing will begin no later than thirty minutes after the start of the question and answer session preceding it, *i.e.*, by 12:30 P.M., November 15, 2021, and 6:30 P.M., November 17, 2021.
