Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy) filed a joint application and supporting testimony requesting an accounting authority order (AAO) for costs incurred during the extreme weather event of February, 2021, also known as Winter Storm Uri. On March 16, 2021, the Commission issued its order addressing whether Evergy Missouri Metro could exclude extraordinary revenues from passing through its fuel adjustment clause. It is now appropriate to proceed with Evergy's request for an AAO. Therefore, Staff shall consult with the other parties and submit a proposed procedural schedule.
