## PUBLIC COUNSEL'S MOTION TO RESCHEDULE TRUE-UP HEARING

COMES NOW the Office of the Public Counsel and for its Motion to Reschedule Trueup Hearing states as follows:

- 1. On April 5, 2007, the Commission issued an order which, *inter alia*, scheduled a true-up hearing for November 8.
- 2. On September 4, the Circuit Court of Cole County issued an order setting oral argument in the consolidated appeals (Case No. 07AC-CC00584 *et al.*) of the Union Electric Company rate case for November 8.
- 3. During the evidentiary hearings in this case, counsel for Staff inquired of all parties present at those hearings as to whether there would be objection to moving the true-up hearing to November 9. No party mentioned any objection.
- 4. On October 31, counsel for Staff sent an email to all parties again asking whether there would be any objection to moving the true-up hearing to November 9, and again there was no objection.
- 5. The Staff supports this request and counsel for KCPL has authorized Public Counsel to state that KCPL does not oppose it.

6. The Commission's Weekly Docket, distributed by email on October 31, shows the true-up hearing beginning on November 8 and continuing through November 9. While the

parties are continuing to work on refining the reconcilement and determining contested issues, it

appears that there will be a limited number of contested issues and that a one-day hearing should

suffice.

7. In order to accommodate both counsel for Public Counsel and counsel for Staff

who will need to be present for both the true-up hearing in this case and the oral argument in

Case No. 07AC-CC00584 et al., Public Counsel requests that the Commission reschedule the

true-up hearing to begin on November 9.

WHEREFORE, Public Counsel respectfully requests that the Commission

reschedule the true-up hearing to begin on November 9, 2007, beginning at 8:30 AM.
