**PUBLIC COUNSEL’S PROPOSED CUSTOMER NOTICE**

COMES NOW the Office of the Public Counsel and in response to the Commission’s Order and Notice states as follows:

1. On February 1, 2007, Kansas City Power & Light Company (KCPL) filed a general rate increase case.
2. On February 6, the Commission issued its Order and Notice, which directed Public Counsel to submit a proposed local public hearing places and dates, and a proposed customer notice, no later than March 28. Although Public Counsel timely filed a pleading suggesting dates and places for local public hearings, it failed to file a proposed customer notice. On May 22, the Commission issued an order directing Public Counsel to file a proposed customer notice no later than June 22.
3. Public Counsel submits the following draft customer notice in response to that order. Because the Commission has not yet set the dates, times, or locations for the local public hearing, there are necessarily some blanks in the proposed notice.

**IMPORTANT NOTICE**

Kansas City Power & Light Company has filed revised electric service tariff sheets with the Missouri Public Service Commission that would increase the

company's Missouri jurisdictional annual gross revenues by \$45 million or approximately 8.3%. For the average residential customer, the increase would be approximately \$6 per month.

The PSC will conduct local public hearings to solicit input from the company's customers. *[NUMBER OF LOCAL PUBLIC HEARINGS, DATES, TIMES AND LOCATIONS HERE]* The PSC will also conduct evidentiary hearings at the PSC offices, 200 Madison Street, Jefferson City, Missouri, October 1-4 and 9-12, 2007, beginning at 8:30 A.M. The buildings where the hearings will be held meet the accessibility standards required by the Americans with Disabilities Act. WHEREFORE, Public Counsel respectfully requests that the Commission approve the proposed customer notice substantially as included herein, subject to modification as necessary once the Commission determines dates, times and locations for the local public hearings.
