**ORDER GRANTING MOTION FOR EXTENSION OF**  
**TIME TO FILE POST-HEARING BRIEFS**

On February 1, 2006, Kansas City Power & Light Company submitted to the Commission proposed tariff sheets intended to implement a general rate increase for electrical service provided in its Missouri service area. The Commission set a procedural schedule on March 29 that required, among other things, post-hearing briefs to be filed no later than November 15, with reply and true-up briefs due no later than November 22.

On November 13, the Staff of the Commission asked for an extension of time to file those briefs. Staff alleges that due to the press of other work, it is unable to meet those deadlines. Staff asks that the Commission reset the deadlines to November 17 and 27, respectively.

The Commission finds Staff's motion reasonable, and will grant it.

**IT IS ORDERED THAT:**


1. The Motion for Extension of Time to File Post-Hearing Briefs filed by the Staff of the Commission is granted.

**TIME TO FILE TRUE-UP REBUTTAL TESTIMONY**

On February 1, 2006, Kansas City Power & Light Company submitted to the Commission proposed tariff sheets intended to implement a general rate increase for electrical service provided in its Missouri service area. The Commission set a procedural schedule on March 29 that required, among other things, true-up rebuttal testimony to be filed no later than November 10.<sup>1</sup>

On November 13, the Office of the Public Counsel asked for an extension of time to file true-up rebuttal testimony. OPC states that their witness, Russ Trippensee, is unable to meet that deadline due to illness. OPC asks for an additional day, and asserts that this one-day extension will not delay the remainder of the procedural schedule.

The Commission finds OPC's motion reasonable, and will grant it.


