**ORDER OPENING A WORKING CASE TO ASSIST IN THE DRAFTING OF A RULE  
TO REVISE COMMISSION RULE 4 CSR 240-3.105**

On January 8, 2014, Dogwood Energy, LLC, filed a petition asking the Commission to promulgate a new rule to revise Commission rule 4 CSR 240-3.105. In an order issued in File No. EX-2014-0205, the Commission has denied that petition, but has directed its Staff to prepare and present a revised rule to the Commission by August 29, 2014. The Commission has created this working file to facilitate Staff's efforts to obtain input from interested stakeholders regarding the drafting of that revised rule.

This file will serve as a repository for documents and comments. Using this file, any person with an interest in this matter may view documents and may submit comments or documents. As this is not a contested case, anyone may file a comment without legal counsel and without *ex parte* constraints. Intervention requests are not necessary to submit comments or view documents.
