ORDER DIRECTING UTILITIES TO EVALUATE IMPACTS OF STANDARD OFFER CONTRACTS

Issue Date: July 25, 2018 Effective Date: July 25, 2018

The Commission opened File No. EW-2018-0078 as a working case to gather information and facilitate discussion regarding the possible amendment of its rules related to cogeneration and net metering. File No. EW-2017-0245 is a separate working case opened to facilitate discussion about emerging issues. On July 24, 2018, Staff filed a motion in both files asking the Commission to direct each investor-owned electric utility to file an evaluation of the impacts, including distribution system impacts, of raising the standard offer contract (SOC) size to 1 MW, 2.5 MW, and 5 MW. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. No later than August 24, 2018, Union Electric Company d/b/a Ameren Missouri, Kansas City Power & Light Company, KCP&L Greater Missouri Operations Company, and The Empire District Electric Company shall each file an evaluation of the impacts, including distribution system impacts, of raising the standard offer contract (SOC) size to 1 MW, 2.5 MW, and 5 MW.

2. This order shall be effective when issued.
