Recognizing that staff is rapidly approaching the finish line in this process of developing a draft set of rule changes to present to the Commission, Dogwood will keep its comments at this time limited and focused.

First, as illustrated by the recent GMO IRP filing, the current process seems to be misinterpreted by the utilities as allowing them to disregard issues concerning existing sources of supply. As Dogwood noted in its comments, GMO did not address issues about Crossroads. Likewise, as noted in DNR's comments, GMO did not address issues concerning retirement of coal plants.

Accordingly, we suggest revision of the beginning of 22.040(1) as follows:

"The utility shall evaluate all existing supply-side resources and identify a variety of new supply-side resource options which the utility can reasonably expect to use, develop, implement, or acquire, and for purposes of integrated resource planning all such supply-side resources shall be considered as potential supply-side resource options."

Second, we suggest including a new 22.040(3)(B) that requires consideration of output limitations that may be imposed by transmission and/or distribution capacities (such as are currently imposed on the Crossroads facility), as follows:

"(B) The analysis shall include the identification of any output limitations imposed on existing or new supply-side resources due to transmission and/or distribution system capacity, in order to ensure that supply-side candidate resource options are evaluated in accordance with any such constraints."

Third, we suggest adding a new 22.040(4)(D) to ensure consideration of additional costs related to backing up intermittent or uncontrollable supply sources, as follows:

"(D) The utility shall include the costs of ancillary and/or back-up sources of supply required to achieve necessary reliability levels in connection with intermittent and/or uncontrollable sources of generation, in the cost of supply-side candidate resource options advanced for purposes of developing the alternative resource plans required by 4 CSR 240-22.060(3)."

Fourth, we suggest clarifying the wording of 22.070(6)(E). Note that subsection 6 requires the utility to "describe and document", and then the sub-sub-sections are a list of required components of the implementation plan. Accordingly, we suggest revising (E) to read:

"Adequate competitive procurement policies to be used in acquisition and development of supply-side resources;"

Finally, a few minor points.

22.020(13)(definition of describe and document) – as written this text seems to stray from a definition to a substantive requirement. Perhaps only stylistic, but more in keeping with "definition" to revise to read: "Describe and document refers to a demonstration of compliance with provisions of this chapter, to be set forth in the technical volume(s) of the triennial compliance filing, in sufficient detail to inform the stakeholders how the utility complied ... etc." Also the last sentence seems redundant to the referenced rule 22.080(11) and does not seem to fit in the definition.

And a side note on "describe and document" – if the intent was to use this phrase everywhere in lieu of just "describe" or just "document", seems there are a few misses. Suggest a word search so staff can make sure it has used the phrase in all desired locations. One example, 22.030(2)(c)3 – "utility shall document"

22.020(22)(definition of historical period) - seems to be a stray "for"

22.030(2)(C)3 – line 9 in redline, perhaps need a comma after "model input data from basic data"
