On November 27, 2017, Union Electric Company d/b/a Ameren Missouri filed an application requesting that the Missouri Public Service Commission approve a tariff authorizing the Renewable Choice Program. On November 27, 2017, the Commission issued an order directing notice of the application and setting a deadline of December 11, 2017 for persons requesting to intervene in this matter.

Sierra Club, Wind on the Wires, Kansas City Power & Light Company, and KCP&L Greater Missouri Operations Company filed timely applications to intervene. Ten days have elapsed, and no party has objected to the applications to intervene.<sup>1</sup> The applications satisfy all requirements of Commission Rule 4 CSR 240-2.075 and intervention will be granted.
