# ORDER DIRECTING NOTICE AND SETTING DEADLINES FOR INTERVENTION AND STAFF RECOMMENDATION

On February 22, 2018, Union Electric Company d/b/a Ameren Missouri filed an application and accompanying tariff sheets seeking approval of two new tariffed programs that are collectively referred to as the "Charge Ahead" program. The application also seeks approval of modifications to Ameren Missouri's existing distribution system extension procedures, variances from portions of the Commission's regulations regarding promotional practices, and the request for an accounting authority order (AAO) for the Charge Ahead program. The proposed tariffs have an April 23, 2018 effective date.

The Commission will provide notice of the application and tariff filing and set a time for requests to intervene and for the Staff of the Missouri Public Service Commission to file a recommendation.

# THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send a copy of this order to the Board of Alderman of the City of St. Louis and to the county commissions of the counties within Union Electric Company d/b/a Ameren Missouri's service territory. 2. The Commission's Public Policy and Outreach Department shall make this notice available to the members of the General Assembly representing the City of St. Louis and to the county commissions of the counties within Union Electric Company d/b/a Ameren Missouri's service territory and to the newspapers and other media serving that area.

3. Any person or entity wishing to intervene in this matter shall file an application to intervene no later than March 14, 2018.

4. The Staff of the Commission shall file a recommendation regarding the Application, Request for Variance and Request for Accounting Authority no later than March 23, 2018.

5. This order is effective when issued.
