FIRST AMENDMENT TO WIRELESS INTERCONNECTION AGREEMENT

BETWEEN

GRAND RIVER MUTUAL TELEPHONE CORPORATION AND

DOBSON CELLULAR SYSTEMS, INC.

This First Amendment ("Amendment") to Interconnection/Compensation Agreement dated December 24, 2001("Agreement") is effective as of the 1st day of June, 2004 (the "Effective Date"), by and between Grand River Mutual Telephone Corporation ("GRMT") with offices at 1001 Kentucky Street, Princeton, MO 64673 and Dobson Cellular Systems, Inc. ("Dobson") with offices at 14201 Wireless Way, Oklahoma City, Oklahoma 73134.

As of the Effective Date, Section 4.3 of the Agreement shall be deemed to be replaced in its entirety by the following:

<u>Transiting Traffic</u>: As of the Effective Date, Dobson is authorized, where its customers have generated Local Traffic to GRMT numbers which are not served through end offices or host switches to which Dobson has established a direct connection pursuant to Sections 4.1 and 4.2 above, to deliver such traffic to GRMT by way of a third party tandem office which maintains a connection with GRMT. Reciprocal compensation for traffic that is transited will be at the rate set forth in Attachment C.

Also as of the Effective Date, Attachment C will be deemed amended to include the following additional language:

<u>Traffic Transited by Dobson Through a Third Party Tandem Office:</u> \$.035/minute

As of the Effective Date, a new Section 4.4 shall be added to the Agreement to state:

Attachment A lists GRMT numbers that are already accessed or which may be accessed by Dobson through the direct connections described in Sections 4.1 and 4.2. This list shall be supplemented by GRMT to the extent that it adds numbers to its inventory. Where Dobson wishes to add or delete direct connections to such numbers it may do so on written notice to GRMT. Where changes are made in direct connections the reciprocal compensation rate will be adjusted to the appropriate rate set forth in Attachment C.

Also as of the Effective Date, Section 5.1 of the Agreement will be deemed amended to state:

5.1 <u>Traffic Subject to Reciprocal Compensation</u>. Reciprocal Compensation is applicable for Transport and Termination of Local Traffic as defined in Section 1.14 to the extent that traffic is otherwise exchanged over the dedicated or transit facilities provided for hereunder and is traffic described

in Section 4. The rates for Reciprocal Compensation are described in Amended Attachment C to this Agreement.
