NOTICE OF DEFICIENCY

On August 28, 2023, Convergence Solutions, Inc. filed an application to provide telecommunications and/or interconnected voice over internet protocol services. That application is deficient in that it is not signed by an attorney licensed to practice law in Missouri, as required by Commission Rule 20 CSR 4240-2.080(1) and 28.011(1)(B). Additionally, the included affidavit attesting to the requirements identified in Section 392.550, Revised Statutes of Missouri (RSMo), was not signed by an officer or general partner of the applicant as required by Subsection 392.550.3, RSMo.

The Commission will not take action on Convergence Solutions, Inc.'s application to provide telecommunications and/or interconnected voice over internet protocol services request until these deficiencies are corrected.
