ORDER APPROVING TARIFF FILINGS IN COMPLIANCE WITH COMMISSION ORDER

On August 20, 2010, the Commission's Staff filed a recommendation that the Commission approve compliance tariffs filed by Atmos Energy Corporation on August 18, 2010.¹ The Commission has reviewed the tariff filings and Staff's verified recommendation and memorandum and finds the tariffs should be approved.
