## ORDER CANCELING SERVICE AUTHORITY

Issue Date: September 18, 2023

Effective Date: October 18, 2023

On August 22, 2023, the Staff of the Commission filed a *Motion to Cancel Interconnected Voice Over Internet Protocol Registration*. In its motion, Staff stated that BTC, Inc. filed a letter with the Commission on August 16, 2023, (Tracking No. BCES-2023-0093) asking the Commission to cancel its Interconnected Voice Over Internet Protocol (IVoIP) authority, as it is no longer doing business in the State of Missouri. The certificate for IVoIP authority had been granted to BTC, Inc. in File No. DA-2017-0116 on November 18, 2016.

On August 31, 2023, the Commission issued an order that anyone wishing to object or to request a hearing do so no later than September 14, 2023. There were no such filings.

The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, the Commission may cancel the certificate based on Staff's motion.

### THE COMMISSION ORDERS THAT:

1. The IVoIP service authority of BTC, Inc. is canceled.
2. This order shall be effective on October 18, 2023.
