On October 29, 2018, Barry Technology Services, LLC requested designation as both a high-cost and low-income Eligible Telecommunications Carrier (ETC) in all areas in Missouri where Barry Technology Services, LLC has been allocated support under Connect America Fund Phase II and under the Federal Communications Commission Lifeline/Disabled program.

Notice of the application shall be sent to all incumbent and competitive local exchange carriers certificated to provide service in Missouri. The Commission will also set a deadline for intervention requests and direct the filing of a recommendation by the Staff of the Commission.

### THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send notice of this application to all eligible telecommunications carriers certified to provide service in Missouri.
2. Any request to intervene shall be filed with the Commission no later than November 12, 2018. Such applications shall be filed with:
