# INTERCONNECTED VOICE OVER INTERNET PROTOCOL REGISTRATION

On November 7, 2018, CRC Communications LLC d/b/a OTELCO filed an application for registration to provide Interconnected Voice over Internet Protocol service in in the Pilot Grove Exchange area. CRC Communications LLC d/b/a OTELCO also filed an application for registration to provide basic local, non-switched local, and interexchange telecommunications services in the Pilot Grove Exchange area, which application was addressed in File No. LA-2019-0135.

The Commission has reviewed the application filed by the CRC Communications LLC d/b/a OTELCO and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo 2016.
