NOTICE OF UNANIMOUS STIPULATION AND AGREEMENT AND ORDER SUSPENDING PROCEDURAL SCHEDULE

On October 3, 2018, the Commission issued its Order Adopting Procedural Schedule and setting this matter for an evidentiary hearing on November 26 and 27, 2018. On November 12, 2018, Ameren Transmission Company of Illinois (ATXI), the Staff of the Missouri Public Service Commission, the Office of Public Counsel, and the Missouri Department of Economic Development – Division of Energy filed a Unanimous Stipulation and Agreement (“Stipulation”) and therein advised the Commission that if approved by the Commission, the Stipulation would resolve all issues related to ATXI’s Application. The Commission will suspend the procedural schedule pending its action on the Stipulation.

THE COMMISSION ORDERS THAT:

1. The Order Adopting Procedural Schedule and setting this matter for an evidentiary hearing on November 26 and 27, 2018, is suspended.

2. This order shall be effective when issued.
