**ORDER APPROVING FUEL
ADJUSTMENT CLAUSE TARIFF AND TRUE-UP**

Issue Date: November 15, 2018

Effective Date: December 1, 2018

The Empire District Electric Company ("Empire") filed a tariff and supporting testimony in both of these cases. The Commission's Staff filed a favorable recommendation, and no opposition was received.

In File No. EO-2019-0096, Empire seeks the Commission's approval of true-up amounts related to the company's fuel adjustment clause ("FAC"). Specifically, the amounts relate to the company's Recovery Period 18. Those amounts are components of the FAC for the company's Accumulation Period 20, which is the subject of File No. ER-2019-0095. In that case, Empire asks to decrease the company's rates per kilowatt hour ("kWh") to \$(0.00085) for primary service and \$(0.00087) for secondary service effective December 1, 2018. For a residential customer using 1,000 kWh per month of secondary service, the tariff

decreases the Fuel Adjustment Charge by approximately \$8.45 per month from \$7.58 to \$(0.87).

On the basis of the verified and uncontested filings, the Commission concludes that the tariff conforms to the applicable statutes, regulations, and tariffs. Therefore, the Commission will approve the tariff.

THE COMMISSION ORDERS THAT:

1. The tariff assigned Tracking No. JE-2019-0061 is approved to become effective on December 1, 2018, subject to true-up and prudence review.
2. The specific tariff sheet approved is:
