ORDER DIRECTING STAFF TO FILE A COMPLAINT

Issue Date: November 28, 2018

Effective Date: November 28, 2018

The Commission opened this case to address the compliance of certain Missouri water corporations with the requirements of Senate Bill 705, which was passed during the last legislative session, and which has been codified at section 393.358, RSMo. That statute requires water corporations that serve more than 1,000 customers to develop a qualification process, and make that process open to all contractors seeking to provide construction and construction-related services on the water corporation's distribution system. RDE Water Company is one of the water corporations subject to the law.

Subsection 393.358.3 required RDE Water Company to file a statement within thirty days after August 28, 2018, confirming that it has established the required qualification process. The statute gives the Commission authority to verify that statement to ensure compliance. In an order issued on August 28, the Commission specifically directed RDE Water Company to file the statement required to comply with the statute. RDE Water Company did not file the required statement. On October 31, the Commission again

directed RDE Water Company to file the required statement. RDE Water Company did not respond.

Section 386.390, RSMo authorizes the Commission to make a complaint on its own motion alleging violation of any provision of law subject to the Commission's authority. To that end, the Commission will direct its Staff to prepare an appropriate complaint against RDE Water Company and to file that complaint before the Commission in a new case.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff is directed to file the complaint against RDE Water Company described in the body of the order no later than December 28, 2018.
2. This order shall be effective when issued.


