ORDER APPROVING DISPOSITION OF REMAINING FUNDS

Issue Date: December 5, 2018 Effective Date: December 15, 2018

On May 24, 2018, the Missouri Public Service Commission issued a Report and Order approving a merger involving Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company (collectively, the "Company"), subject to a number of conditions. One of those conditions required the Company to provide certain upfront bill credits to its customers. On November 16, 2018, the Company filed a notice with the Commission stating that the upfront bill credits have been provided to its customers.

The Company also states that certain bill credit funds in the total amount of \$7,971.86 were not applied to customer bills due to rounding and customers leaving the system. The Company requests that the Commission authorize it to provide those remaining funds to the Mid America Assistance Coalition to be applied to the Dollar Aide program, which is administered for the purpose of providing energy assistance to customers in need. The Company represents that Commission Staff, the Office of the Public Counsel, and Midwest Energy Consumers Group were notified of the request and do

not oppose the requested relief. Ten days have elapsed and no party has objected to the request.¹ The Commission finds the request reasonable and will grant it. The Commission will make this order effective in ten days to facilitate assistance to the Company's customers.

THE COMMISSION ORDERS THAT:

- 1. Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company's request to dispose of the remaining bill credit funds is granted. Any remaining upfront bill credit funds shall be provided to the Mid America Assistance Coalition to be applied to the Dollar Aide program.
 - 2. This order shall be effective on December 15, 2018.
