NOTICE OF DEFICIENCY

Issue Date: May 2, 2023

On May 1, 2023, the Commission received a letter from GridLiance High Plains, LLC, signed by Julie N. Krauss, Principal Business Analyst, NextEra Energy Transmission. The letter requested a 30-day extension to file the annual report of GridLiance. The letter indicates that GridLiance had previously been granted an extension of time until May 15, 2023.

Commission Rule 20 CSR 4240-10.145(1) requires that a utility file its annual report by April 15 each year unless an extension is granted. Commission Rule 20 CSR 4240-10.145(7) states that a utility may request an extension of greater than 30 days by filing “a pleading in compliance with the requirements of Chapter 2” of the Commission’s rules. Commission Rule 20 CSR 4240-2.080(1) requires that every pleading be signed by an attorney of record or by a person representing themselves. There is no indication from the letter than Julie N. Krauss is a Missouri-licensed attorney.

Therefore, GridLiance is notified that the Commission will not take any action on its request for an extension of time more than 30 days after April 15 until the deficiency is corrected. The Commission will leave this file open until May 31, 2023. If the deficiency is not corrected by that time, the Commission will reject the request and close this file.
