On December 12, 2018, the Commission issued an Order Granting Application for Designation as an Eligible Telecommunications Carrier (“ETC”). That Order inadvertently referred to the application requesting a wireless ETC designation. However, the applicant requested wireline ETC designation. This order corrects the December 12, 2018 order *nunc pro tunc* and approves the wireline ETC designation, which was the Commission’s intent.

THE COMMISSION ORDERS THAT:

1. The Order Granting Application for Designation as an Eligible Telecommunications Carrier issued on December 12, 2018 is corrected *nunc pro tunc* as described above.

2. This order shall be effective when issued.
