## ORDER DIRECTING STAFF RECOMMENDATION AND ESTABLISHING TIME TO RESPOND

Union Electric Company d/b/a Ameren Missouri has filed its compliance tariff following Commission issuance of a Report and Order to resolve this case. That compliance tariff carries a January 12, 2019, effective date, but Ameren Missouri has asked the Commission to approve it to be effective on January 1, as was contemplated in the approved stipulation and agreement and so that the beginning of the first accumulation period under the RESRAM will coincide with the beginning of the accounting month and year. The Commission will direct its Staff to file a recommendation regarding the tariff and will establish a time for any other party to file a recommendation if they choose to do so.

#### THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a recommendation regarding the compliance tariff filed by Union Electric Company d/b/a Ameren Missouri (Tariff No. YE-2019-0117) no later than December 18, 2018.

- 2. Any other party wishing to file a recommendation regarding the compliance tariff filed by Union Electric Company d/b/a Ameren Missouri (Tariff No. YE-2019-0117) shall do so no later than December 18, 2018.
  - 3. This order shall be effective when issued.
