ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On December 20, 2018, the Staff of the Missouri Public Service Commission (Staff) filed a motion requesting that the Commission cancel the certificate of interchange service authority and the applicable tariff of U.S. South Communications, Inc. d/b/a U.S. South (Company) in the State of Missouri. On November 5, 1996, the Commission granted the Company a certificate to provide intrastate interexchange service in Case No. TA-97-96. The Company has a currently effective tariff, Tariff No. JX-2003-1012. The Staff's motion states that the Company wishes to voluntarily relinquish its authority and to have all of its applicable tariffs cancelled.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.
