On December 21, 2018, Union Electric Company, d/b/a Ameren Missouri, filed tariff sheets (Tariff Tracking No. YE-2019-0133) to comply with the Commission's *Order Approving Stipulation and Agreement and Granting Waivers* (Commission Order). The tariff sheets bear a January 20, 2019 effective date. The Commission would be aided by a recommendation from its Staff. Therefore, the Commission directs Staff to file a recommendation regarding the tariff sheets no later than January 7, 2019.

Additionally, on December 31, 2018, Ameren Missouri filed a request to revise its Technical Resource Manual and its Deemed Savings Table which had also been approved in the Commission Order. The Commission will set a deadline for filing responses to that request.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding the compliance tariff, Tariff Tracking No. YE-2019-0133, no later than January 7, 2019.

2. Any other party may also file a response to Tariff Tracking No. YE-2019-0133 no later than January 7, 2019. 3. Any responses to the *Request to Revise Technical Resource Manual and Deemed Savings Table* filed by Union Electric Company, d/b/a Ameren Missouri, on December 31, 2018, shall be filed no later than January 22, 2019.
