## ORDER CANCELLING CERTIFICATES OF SERVICE AUTHORITY

Issue Date: January 17, 2019

Effective Date: January 17, 2019

On December 20, 2018, the Staff of the Missouri Public Service Commission (“Staff”) filed a motion requesting that the certificates of interexchange service authority of Flowroute, Inc. and Flowroute CLEC, Inc. (“Companies”) be cancelled. On December 20, 2018, the Commission issued its *Order Establishing Time to Respond to Motion*, which gave anyone wishing to respond to Staff’s Motion or otherwise to request a hearing until no later than December 30, 2018, to do so. No such response or request has been filed. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> The Commission will cancel the certificates based upon Staff’s motion.

### THE COMMISSION ORDERS THAT:

1. The certificates of service authority<sup>2</sup> to provide basic local telecommunications, non-switched local, and intrastate interexchange

telecommunications services in Missouri of Flowroute, Inc. and Flowroute CLEC, Inc. are cancelled.
