ORDER APPROVING REVISED TECHNICAL RESOURCE MANUAL AND DEEMED SAVINGS TABLE

Issue Date: February 27, 2019 Effective Date: March 29, 2019

On December 5, 2018, the Commission approved a stipulation and agreement in this case, which, among other things required Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) to file an updated Technical Resource Manual (TRM), and an updated Deemed Savings Table. On December 31, 2018, Ameren Missouri filed a Request to Revise Technical Resource Manual and Deemed Savings Table. On January 11, 2019, Ameren Missouri filed corrected Appendix F and Appendix I in order to incorporate suggestions made to it by the Staff of the Commission (Staff). Staff filed a recommendation on January 22, 2019.

In its recommendation, Staff explained that the proposed TRM revisions in Ameren Missouri's request were primarily based on: incorporating the Evaluation, Measurement, and Verification (EM&V) results for Ameren Missouri's Missouri Energy Efficiency Investment Act (MEEIA) Cycle 2 program year 2017; updating incremental cost calculations; and adding new sections regarding demand response. Staff reviewed

Ameren Missouri's request and corrected appendices, and found them to be in compliance with the approved agreement. Staff recommended the Commission approve the request as updated with corrected Appendix F and corrected Appendix I.

The Commission has reviewed the filings and determines that the revised TRM and Deemed Savings Table as corrected (Appendix F and Appendix I) are in compliance with the Commission's December 5, 2018 order and will approve them.

THE COMMISSION ORDERS THAT:

- 1. The revised Technical Resource Manual and Deemed Savings Table filed by Union Electric Company d/b/a Ameren Missouri on December 31, 2018, as corrected by Appendix F and Appendix I filed on January 11, 2019, are approved.
 - 2. This order is effective on March 29, 2019.
 - 3. This file may close on March 30, 2019.
