# NOTICE THAT TARIFF SHEETS WILL BECOME EFFECTIVE

Issue Date: September 14, 2022

On August 23, 2022, Union Electric Company d/b/a Ameren Missouri file revised tariff sheets, Tracking No. YE-2023-0044, designed to implement the "Renewal Period" to extend its Charge Ahead – Electric Vehicles Program through December 31, 2024. The Renewal Period was contemplated in paragraph 10 of the *Stipulation and Agreement* filed on August 8, 2019, and approved by the Commission on October 17, 2019. Ameren Missouri filed a substitute tariff sheet on September 7, 2022.

The Commission set a time for responses and directed the Staff of the Commission to respond. Staff filed its response on September 7, 2022. Staff stated it does not object to the extension of the program since the proposed budget is not increasing. Staff noted, however, that it had not fully vetted the information that Ameren Missouri stated it relied upon in making the decision that the data supported the extension. No other responses were received.

The Commission has reviewed the tariff sheets implementing the Renewal Period for the Charge Ahead – Electric Vehicles Program through December 31, 2024 and Staff's

response. The Commission will allow the tariff sheets to take effect on September 22, 2022, by operation of law.
