ORDER RECOGNIZING NAME CHANGE

On March 1, 2019, Network Billing Systems, L.L.C. requested that the Commission recognize its name change to Fusion Connect LLC A d/b/a for Fusion LLC. It also requested that it be exempt from retail tariffing, and withdrew its existing retail tariff, as it is allowed to do by Section 392.461, RSMo. The Commission's Staff filed a recommendation on March 20, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Network Billing Systems, L.L.C. to Fusion Connect, LLC A d/b/a for Fusion LLC.
2. This order shall be effective on March 30, 2019.
