**ORDER RELIEVING STAFF OF THE OBLIGATION  
TO FILE A RECOMMENDATION ON TARIFF**

On November 6, 2023,<sup>1</sup> the Commission issued an *Order Canceling Prehearing Conference and Directing Staff Recommendation on Tariff* in which it directed the Staff of the Commission (Staff) to file a recommendation no later than November 13 on Spire’s proposed revised tariff sheet, filed on October 2 (assigned Tracking No. JG-2024-0044).

On November 9, Staff filed a *Motion for Extension of Time* in which to file its recommendation until such time as a decision is made by the Commission on the application of Spire Missouri Inc. d/b/a Spire for a certificate of convenience and necessity to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Platte County, Missouri as an expansion of its existing certificated areas.

Rather than granting Staff an extension of time to a date uncertain by which to file a recommendation on the proposed revised tariff sheet, the Commission will relieve Staff of its obligation to file a recommendation at this time.
