## ORDER CANCELING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: November 22, 2023 Effective Date: December 22, 2023 On October 20, 2023, Telecom Management, Inc. d/b/a Pioneer Telephone filed a request to cancel its certificate of service authority to provide interexchange telecommunication service in the State of Missouri, as well as its MO P.S.C. No. 1 tariff under Tracking No. YX-2005-0170.

The Commission requested a recommendation from its Staff (Staff). Staff recommended that the Commission grant Pioneer Telephone's request and cancel the Company's registration of service authority.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo (2016), which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

The Commission issued notice and allowed time to request a hearing. There were no responses. The Commission need not hold a hearing if, after proper notice

and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, the Commission may cancel the certificate based on the Company's request.

Based on its review of the request of Pioneer Telephone and Staff's recommendation, the Commission finds that the certificate of service authority granted to Pioneer Telephone shall be canceled.

## THE COMMISSION ORDERS THAT:

1. The certificate of service authority issued to Telecom Management, Inc. d/b/a Pioneer Telephone to provide interexchange telecommunications service in the state of Missouri is canceled.

Telecom Management, Inc. d/b/a Pioneer Telephone tariff assigned
Tracking No. YX-2005-0170 is canceled.

3. This order shall be effective December 22, 2023.

4. This file shall close December 23, 2023.
