# ORDER CANCELING REGISTRATION

Issue Date: November 27, 2023 Effective Date: December 7, 2023

On November 1, 2023, Onestream Networks, LLC (Onestream) notified the Commission that the company no longer wished to be registered to provide Interconnected Voice over Internet Protocol (IVoIP) service in the State of Missouri. The Commission granted Onestream registration in File No. DA-2018-0101.

On November 8, 2023, the Commission issued an *Order Establishing Time to*\*Respond to the company's request.

No objections or requests for a hearing were filed. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup>

Based on Onestream's request, the Commission finds that the IVoIP registration granted to Onestream shall be canceled.

### THE COMMISSION ORDERS THAT:

1. The registration to provide Interconnected Voice over Internet Protocol services granted to Onestream Networks, LLC in File No. DA-2018-0101, is canceled.
