ORDER ESTABLISHING TIME TO RESPOND

On March 24, 2023, the Staff of the Commission (Staff) filed a motion requesting the Commission cancel or revoke the certificates to provide basic local exchange, intrastate interexchange and non-switched local exchange telecommunications services and the registration to provide interconnected voice over internet protocol (IVoIP) services of SRInternet, LLC. The Commission granted SRInternet, LLC certificates to provide basic local exchange, intrastate interexchange and non-switched local exchange telecommunications services in File No. LA-2020-0300. The Commission granted SRInternet, LLC registration to provide IVoIP service in File No. DA-2020-0299.

Subsection 392.550(6), RSMo, provides that the Commission may revoke an IVoIP registration for failure to comply with the requirements of Section 392.550, RSMo. The requirements include filing annual reports, filing a Statement of Revenue report, and paying an annual assessment as prescribed by the Commission.

Subsection 392.410(5), RSMo provides the Commission authority to alter or modify any telecommunications certificate of service after notice and hearing.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may revoke the telecommunications certificates and IVoIP registration based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to respond or file a motion for hearing.

THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing an appropriate pleading no later than April 7, 2023.
2. This order shall be effective when issued.
