## ORDER SETTING ADDITIONAL LOCAL PUBLIC HEARINGS

Effective Date: January 13, 2010

The Commission postponed three local public hearings on January 7, 2010, due to adverse weather. This order will reschedule those three hearings in Mexico, Moberly, and Kirksville. Also, due to anticipated large turnout, the Commission will schedule two additional local public hearings in St. Louis. For the same reason, the previously scheduled local public hearing in Excelsior Springs will be moved to a larger venue.

The Commission will also establish a listening post at the Wainwright State Office Building from 9:00 a.m. to 3:30 p.m. on Thursday, January 21, 2010. Staff members will be present at that location to answer questions from the public. Any other party who wishes to send persons to that location to answer questions may do so. Members of the public may also record a video statement at that location.

### IT IS ORDERED THAT:

1. The Commission shall hold a local public hearing on Tuesday, January 19, 2010 from 12:00 Noon until 3:00 p.m., or until all persons who wish to testify have done so, whichever is sooner, at Harris Stowe State University, Main Auditorium, Room 112, 3026 Laclede, St. Louis, Missouri 63101. This is a relocation of the previously scheduled hearing at Harris Stowe.

2. The Commission shall hold a local public hearing on Tuesday, January 19, 2010, from 6:00 p.m. to 9:00 p.m., or until all persons who wish to testify have done so, whichever is sooner, at Holiday Inn Southwest/Viking Conference Center, 10709 Watson Road, Salon A, St. Louis, Missouri 63127.

3. The Commission shall hold a local public hearing on Wednesday, January 20, 2010, from 12:00 p.m. to 4:00 p.m. and again from 6:00 p.m. to 9:00 p.m., or until all persons who wish to testify have done so, at University of Missouri-St. Louis, One University Boulevard, Millennium Student Center Building, North Campus, Century Room B & C, St. Louis, Missouri 63121.

4. The Commission shall hold a local public hearing on Wednesday, January 27, 2010, from 6:00 p.m. until 9:00 p.m., or until all persons who wish to testify have done so, whichever is sooner, at Excelsior Springs High School, Commons, 612 Tiger Drive, Excelsior Springs, Missouri 64024. This is a relocation of the previously scheduled hearing in Excelsior Springs.

5. The Commission shall hold a local public hearing on Thursday, January 28, 2010, from 6:00 p.m. until 9:00 p.m., or until all persons who wish to testify have done so, whichever is sooner, at Mexico High School – Emmons Hall, 639 North Wade, Mexico Missouri 65265.

6. The Commission shall hold a local public hearing on Tuesday, February 2, 2010, from 6:00 p.m. until 9:00 p.m., or until all persons who wish to testify have done so, whichever is sooner, at Truman State University, Student Union, 901 South Franklin Street, Kirksville, Missouri 63501.

7. The Commission shall hold a local public hearing on Wednesday, February 3, 2010, from 6:00 p.m. until 9:00 p.m., or until all persons who wish to testify have done so, whichever is sooner, at Moberly Area Community College, Auditorium, 101 College Ave., Moberly, Missouri 65270.

8. The Commission will also establish a listening post at the Wainwright State Office Building, 111 N. 7<sup>th</sup> St., St. Louis, Missouri 63101, from 9:00 a.m. to 3:30 p.m. on Thursday, January 21, 2010. Commission Staff members will be present at that location to answer questions from the public. Any other party who wishes to send persons to that location to answer questions may do so. Members of the public may also record a video statement at that location.

9. The local public hearings shall be held in facilities that meet the accessibility requirements of the Americans with Disabilities Act. Any person who needs additional accommodation to participate in the hearings should call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 before the hearings.

10. The Data Center of the Missouri Public Service Commission shall serve a copy of this order upon the county commission of each county in Union Electric Company, d/b/a AmerenUE's service area, as well as upon the governing body for the City of St. Louis.

11. The Public Information Office of the Missouri Public Service Commission shall send a copy of this order to members of the General Assembly and to the media that serve the affected portion of Union Electric Company, d/b/a AmerenUE's service area.

12. This order shall become effective immediately upon issuance.
