On February 20, 2019, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company ("the Companies") filed a Motion for Extension of Time to File 2019 Annual Integrated Resource Plan Updates. The motion represents that the Companies are meeting with Staff to determine MEEIA Cycle 3 costs to be used in the IRP Annual Update. The Companies state they need until August 31, 2019 to incorporate those costs into the Annual Update. They further state that Staff and the Office of the Public Counsel do not oppose this request.

The Commission set a February 25, 2019 deadline for parties to respond to the Companies' motion. No party responded. Thus, the Commission will take up the motion unopposed. The Commission finds the motion reasonable, and will grant it.
