ORDER RECOGNIZING NAME CHANGE

Issue Date: April 10, 2019

Effective Date: May 3, 2019

On February 25, 2019, Electric Lightwave, LLC d/b/a Integra Telecom filed notice informing the Commission that it has changed the name under which it does business in Missouri to Allstream. Subsequently, on April 3, it submitted a revised tariff to reflect its new name. That tariff will become effective on May 3. The Commission's Staff filed a recommendation on April 10, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change. The Commission will do so.

This order will be made effective on May 3, to coincide with the effective date of the new tariff.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Electric Lightwave, LLC d/b/a Integra Telecom to Electric Lightwave, LLC d/b/a Allstream.
2. This order shall be effective on May 3, 2019.

3. This file shall be closed on May 4, 2019.


