## ORDER CANCELING CERTIFICATE

Issue Date: April 18, 2019 Effective Date: May 18, 2019

On March 14, 2019, Crown Castle Fiber LLC, successor in interest to Access Fiber Group, Inc., (collectively, the "Company") filed an application requesting the certificate of service authority and accompanying tariff granted to Access Fiber Group, Inc. to provide non-switched local exchange and interexchange telecommunication service in the State of Missouri be cancelled. The Commission granted the Company a certificate of service authority to provide interexchange telecommunications services in File No. TA-2010-0283.

The Company states that Access Fiber Group does not exist as a separate corporate entity, serve any customers, or have any active operations in Missouri.

On March 14, 2019, the Commission issued an order allowing time to object or request a hearing. No objections or hearing requests were received. The order also directed Staff to file a recommendation. On March 29, 2019, Staff filed its *Motion to Cancel Certificate of Service Authority and Tariff* stating that there are no pending actions for either company before the Commission and both companies are current on all assessments and annual report requirements. Staff recommends the Commission cancel the company's certificate of service authority to provide telecommunications services.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the application and Staff's recommendation, the Commission finds that the certificate of service authority granted the company, shall be canceled.

## THE COMMISSION ORDERS THAT:

- The certificate of authority granted in Case No. TA-2010-0283 to Access Fiber
   Group, Inc., and Tariff No. YC-2010-0609 shall be canceled.
  - 2. This order shall become effective on May 18, 2019.
  - 3. This file may be closed on May 29, 2019.
