ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On May 7, 2019, the Staff of the Missouri Public Service Commission filed a motion requesting that Zito Missouri-Kansas, LLC's ("Zito") registration to provide Interconnected Voice over Internet Protocol service in the State of Missouri be cancelled at the company's request. The Commission granted Zito registration to provide Interconnected Voice over Internet Protocol service in the State of Missouri in File Number DA-2017-0034.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the registration based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
