# ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: May 14, 2019 Effective Date: May 26, 2019

On February 6, 2019, the Commission issued its Report and Order authorizing Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) to file tariff sheets to implement an electric vehicle corridor charging program. On April 26, 2019, Ameren Missouri filed tariff sheets (Tariff No. YE-2019-0192) purporting to comply with the Commission's order. The tariff sheets have a May 26, 2019 effective date.

The Commission ordered its Staff to file a recommendation regarding Ameren Missouri's tariff by May 7, 2019. The Commission also directed any other party wishing to respond to the tariff do so by May 7, 2019, and responses to Staff's recommendation to be filed by May 13, 2019. Staff filed its recommendation on May 7, 2019, stating that it examined the tariff sheets and found them to comply with the Commission's order. Staff recommended that the tariff sheets be approved. No other responses were received.

After reviewing the tariffs and the Staff recommendation, the Commission concludes that Ameren Missouri's tariff sheets comply with the Commission's Report and Order. Therefore, the Commission will approve the tariff sheets.

## THE COMMISSION ORDERS THAT:

- 1. Tariff sheets, bearing Tariff No. YE-2019-0192, filed by Union Electric Company d/b/a Ameren Missouri on April 26, 2019, are approved to become effective on May 26, 2019.
