# **ORDER GRANTING EXTENSION TO FILE RATE DESIGN CASE**

KCP&L Greater Missouri Operations Company's (GMO's) 2016 general rate case was resolved through a stipulation and agreement, which the Commission approved on September 28, 2016. One provision of the approved stipulation and agreement required GMO to file a new rate design case by June 30, 2019.<sup>1</sup> On May 9, 2019, GMO filed a motion asking that it be allowed an additional year to file the required rate design case. The motion represents that all signatories to the stipulation and agreement have been consulted, and that none object to the extension.

More than ten days have passed since GMO filed its motion for extension and no party has responded to that motion.<sup>2</sup> Therefore, the Commission will take up the motion as unopposed.

The Commission finds the unopposed motion to be reasonable and will grant the requested extension.
