ORDER CANCELING REGISTRATION

Issue Date: May 30, 2019 Effective Date: June 29, 2019

On May 7, 2019, Staff filed a motion requesting the Commission cancel Zito Missouri-Kansas, LLC's ("Zito") registration to provide Interconnected Voice over Internet Protocol service ("IVoIP") in the state of Missouri. The Commission granted Zito its IVoIP registration in the state of Missouri in File No. DA-2017-0034.

Staff states in its motion that on April 30, 2019, the company notified the Commission that it no longer wished to be registered as an IVoIP provider in Missouri.

On May 10, 2019, the Commission issued an Order Establishing Time to Respond allowing parties to file an objection or request a hearing no later than May 20, 2019. No objections or requests for a hearing were filed.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on Zito's request and Staff's motion, the Commission finds that the IVoIP registration granted to Zito Missouri-Kansas, LLC, shall be canceled.
