On December 26, 2023, Southwestern Bell Telephone Company d/b/a AT&T Missouri filed a letter with the Commission, notifying it that the interconnection agreement between AT&T Missouri and Crown Castle Fiber LLC, adopted on June 29, 2021, in File No. IK-2021-0403, has been terminated as of November 27, 2023. The letter also stated that the interconnection agreement between AT&T Missouri and WANRack, LLC, adopted on February 5, 2020, in File No. IK-2020-0130, has been terminated as of November 20, 2023.
