#### ORDER GRANTING APPLICATIONS TO INTERVENE

On July 3, 2019, Union Electric Company d/b/a Ameren Missouri filed tariff sheets designed to implement a general rate change. On July 5, 2019, the Midwest Energy Consumer Group (MECG) filed an application to intervene. Additionally, the Consumers Council and Renew Missouri Advocates, d/b/a Renew Missouri, each filed applications to intervene on July 8, 2019.

More than ten days have passed since the applications to intervene were filed and no one has responded to the applications. The Commission finds that allowing MECG, Consumers Council, and Renew Missouri to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant the applications to intervene.

1. The applications to intervene of the Midwest Energy Consumer Group, the Consumers Council, and Renew Missouri Advocates, d/b/a Renew Missouri are granted.
