### ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On July 26, 2019, the Staff of the Missouri Public Service Commission filed a motion requesting that Talk America Services, LLC's ("Talk America") certificate of service authority to provide competitive local exchange services and intrastate interexchange service authority in the State of Missouri be cancelled at the company's request. The Commission granted Talk America a certificate of service authority to provide competitive local exchange services and intrastate interexchange service authority in the State of Missouri in File Number LA-2015-0069.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
