NOTICE ACKNOWLEDGING WITHDRAWAL OF MOTION AND CLOSING FILE

On July 25, 2019, the Staff of the Missouri Public Service Commission (Staff) filed a motion to cancel the certificates of service authority to provide interexchange and competitive local exchange telecommunication services of Talk America Services ("Talk America"), in the State of Missouri.

On August 6, 2019, Staff filed its *Motion To Withdraw* based on a July 31, 2019 Company filing which stated Talk America does not seek to cancel its certificate of service authority, but only to discontinue service to its existing Missouri customer base.

Commission Rule 4 CSR 240-2.116(1) permits a movant to voluntarily dismiss its motion without an order of the Commission at any time before prepared testimony has been filed or oral evidence has been offered. No prepared testimony or oral evidence has been offered in this case. Therefore, the Commission acknowledges that Staff has withdrawn its motion. With Staff's

motion having been withdrawn, no further action is required and this file may be closed.

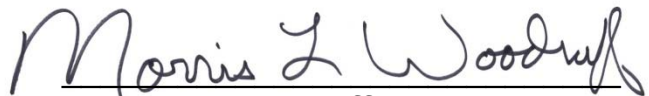
