On August 6, 2019, MGM Interconnect, LLC filed an application for certificate to provide basic local exchange, intrastate interexchange, and non-switched local exchange telecommunications services in all exchanges in the State of Missouri, as permitted by Section 392.611.4, RSMo 2016 and Section 392.550, RSMo 2016.

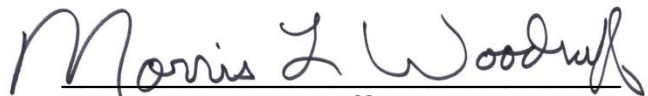
