**ORDER RELIEVING STAFF OF THE OBLIGATION
TO FILE A RECOMMENDATION**

On October 26, 2023, Heidi Orton filed an application with the Commission requesting a change of electric supplier from Eversource Missouri West, Inc. d/b/a Eversource Missouri West to Platte-Clay Electric Cooperative, Inc.

On October 27, 2023, the Commission directed the Staff of the Commission (Staff) to file an investigative report and recommendation regarding the application. On December 12, 2023, the Commission extended the deadline for Staff to file its investigative report and recommendation to January 25, 2024.

On January 22, 2024, Ms. Orton, Eversource Missouri West, Inc. d/b/a Eversource Missouri West, and Platte-Clay Electric Cooperative, Inc. filed a Stipulation and Agreement, which if approved by the Commission, would resolve the matter. Therefore, the Commission will relieve Staff of its obligation to file a recommendation at this time.

THE COMMISSION ORDERS THAT:

1. Staff is relieved of its obligation to file a recommendation on Ms. Orton’s application.

2. This order is effective when issued.
