ORDER APPROVING TARIFFS IN COMPLIANCE WITH COMMISSION REPORT AND ORDER

Issue Date: April 27, 2011 Effective Date: May 4, 2011

On June 4, 2010, Kansas City Power & Light Company submitted to the Commission proposed tariff sheets intended to implement a general rate increase for electrical service provided in its Missouri service area. The Commission issued a Report and Order on April 12, 2011,¹ in which it rejected KCPL's tariffs, but allowed KCPL to file tariffs that comport with the Report and Order no later than April 18. The Commission also ordered any objections to the tariffs to be filed no later than April 22.

On April 18, KCP&L filed tariff sheets which the Commission denominated Tariff Nos. YE-2011-0523 and YE-2011-0524, as amended by substitute sheets filed on April 19, 20 and 26. On April 26, KCP&L also filed Tariff No. YE-2011-0534.

KCP&L stated that these tariffs comply with the Commission's Report and Order, and KCPL requested that the tariffs become effective for service on and after May 4.

Contemporaneously with those tariffs, KCP&L filed Motions for Expedited Consideration, requesting Commission approval by May 4. In those motions, KCP&L pointed out that the original tariffs were filed on June 4, 2010, thereby meaning that the Commission's time to decide a rate case pursuant to Section 393.150.1 RSMo will expire on May 4.

The Staff of the Missouri Public Service Commission filed its Recommendation on April 22. Staff stated that the above-referenced tariff sheets comply with the Commission's Report and Order, and recommended that the Commission approve them. Staff also stated that the tariff sheets, as clarified, state good cause for the Commission to approve the tariffs on less than 30 days' notice

The Office of the Public Counsel ("OPC") and Robert Wager ("Mr. Wagner") objected to certain tariff sheets on April 22, stating that they did not reflect a stipulation and agreement regarding outdoor lighting issues that the Commission had approved. On April 26, however, KCP&L filed Tariff No. YE-2011-0534, and represented that KCP&L, OPC, and Mr. Wagner agreed that the tariff filed on April 26 reflects their agreement. Further, KCP&L represented that Staff is not opposed to that tariff.

The Commission has reviewed the above-mentioned filings, and determines that the filings comply with the Commission's order. The Commission further finds that good cause exists for KCPL to be excused from the Section 393.140(11) requirement that tariffs have a 30-day effective date.

To constitute good cause, the reason or legal excuse given "must be real not imaginary, substantial not trifling, and reasonable not whimsical." No party objects to KCP&L's and Staff's assertion that the Commission has good cause to order the tariffs into effect before the 30-day effective date. The Commission independently finds and concludes that it has good cause to order the tariffs into effect before the 30-day effective date.

THE COMMISSION ORDERS THAT:

- The Motions for Expedited Treatment filed by Kansas City Power & Light Company are granted.
 - 2. All objections to the tariffs approved in this order are overruled.
- 3. The following tariff sheets in Tariff No. YE-2011-0523 and YE-2011-0524, issued April 12, 2011, as amended by substitute sheets filed on April 19, 2011, and April 20, 2011, and April 26, 2011, and Tariff No. YE-2011-0534, issued April 26, 2011, are hereby approved to become effective on May 4, 2011:
