ORDER GRANTING LEAVE TO AMEND APPLICATION EXHIBITS

On January 3, 2024, Union Electric Company d/b/a Ameren Missouri and Tri-County Electric Cooperative (collectively, "Joint Applicants"), jointly filed an application seeking Commission approval of a territorial agreement.

On January 29, 2024, Joint Applicants filed a *Joint Motion to Amend Exhibits to Application for Approval of a Territorial Agreement* in which they requested that they be allowed to amend Exhibits A and B to Appendix A (the territorial agreement) of their application. The motion states that Exhibits A and B contain the legal description of the exclusive service territories of each company. Following land surveys, Joint Applicants now seek to amend Exhibits A and B to more accurately reflect the legal description of each company's exclusive service territory.

The Commission will grant Joint Applicants' motion.

THE COMMISSION ORDERS THAT:

1. Joint Applicants are granted leave to amend Appendix A of their application by filing revised Exhibits A and B to Appendix A.

2. This order shall be effective when issued.
